This Fund Update was first made publicly available on 13 February 2017.

### What is the purpose of this update?

This document tells you how SuperLife<sup>Income</sup> Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

SuperLife<sup>Income</sup> invests in income assets. Designed for investors that want to protect the value of their investment. Negative annual returns may occur once in every 10 – 20 years on average.


### Example of how this applies to an investor

Jess had \$10,000 in the fund on 28 October 2016 and did not make any further contributions. On 31 December 2016, Jess incurred a loss after fund charges were deducted of -\$110 (that is -1.10% of her initial \$10,000). Jess paid other charges of \$2 (Jess received statements and other SuperLife communications electronically and was not charged the paper statements fee). This gives Jess a total loss after tax of -\$112 for the 2 months and 4 days.
