What is the purpose of this update?

This document tells you how SuperLife Growth has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests mostly in growth assets. Designed for investors that want a growth investment option. Negative annual returns may occur once in every 3-5 years on average.

What are the risks of investing?

Risk indicator for SuperLife Growth ¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

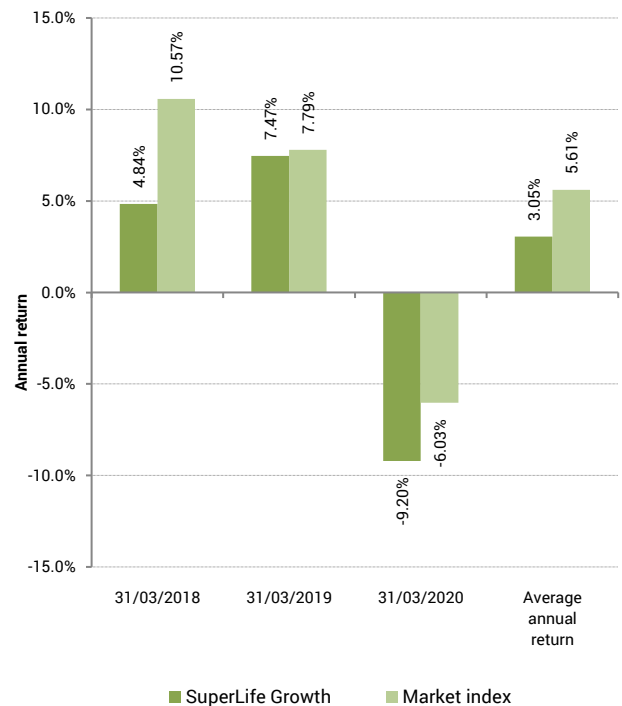

How has the fund performed?

GST is included in the fund charges set out above.

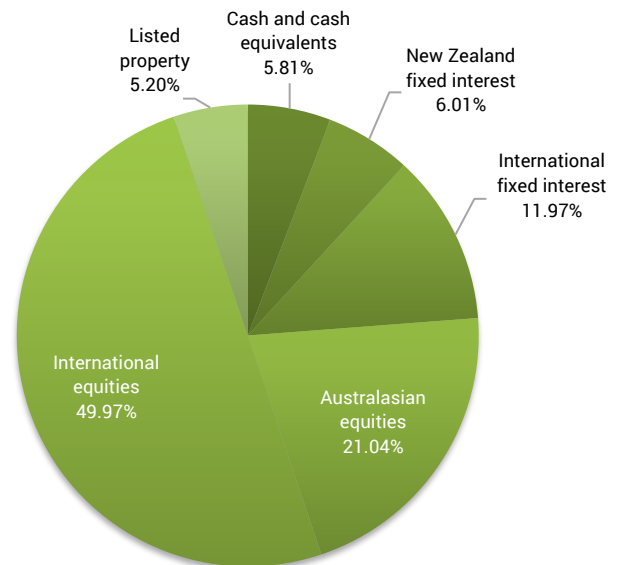
Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$920 (that is -9.20% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$932 for the year.

Currency hedging

The fund's foreign currency exposure may be hedged to the New Zealand dollar, and hedging levels will vary between 0% and 110%. As at 31 March 2020, 78.94% of the fund's foreign currency exposure was hedged.

Material changes

There have been no material changes to the nature of SuperLife Invest, the investment objectives and strategy of the fund, or the management of the scheme over the quarter ended 31 March 2020.

Notes

- Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 1 year and 7 months of market index returns.
