### SuperLife KiwiSaver scheme

### Emerging Markets Fund

For the quarter ended 31 March 2017.

This fund update was first made publicly available on 28 April 2017.

### What is the purpose of this update?

This document tells you how the Emerging Markets Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The Emerging Markets Fund is designed to provide a return (after tax, fees and other expenses) that reflects the after-tax return on international share markets of emerging economies.

### What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

### Other specific risks

There are other risks that may increase the risk to returns for investors, which are not reflected in the risk indicator. These risks include investment management risk. In particular, while the SuperLife KiwiSaver scheme's philosophy is that a passive approach to investing will deliver better long-term results, we make some active management decisions. There is a risk that this may result in the fund achieving a return that is lower than its investment objective.

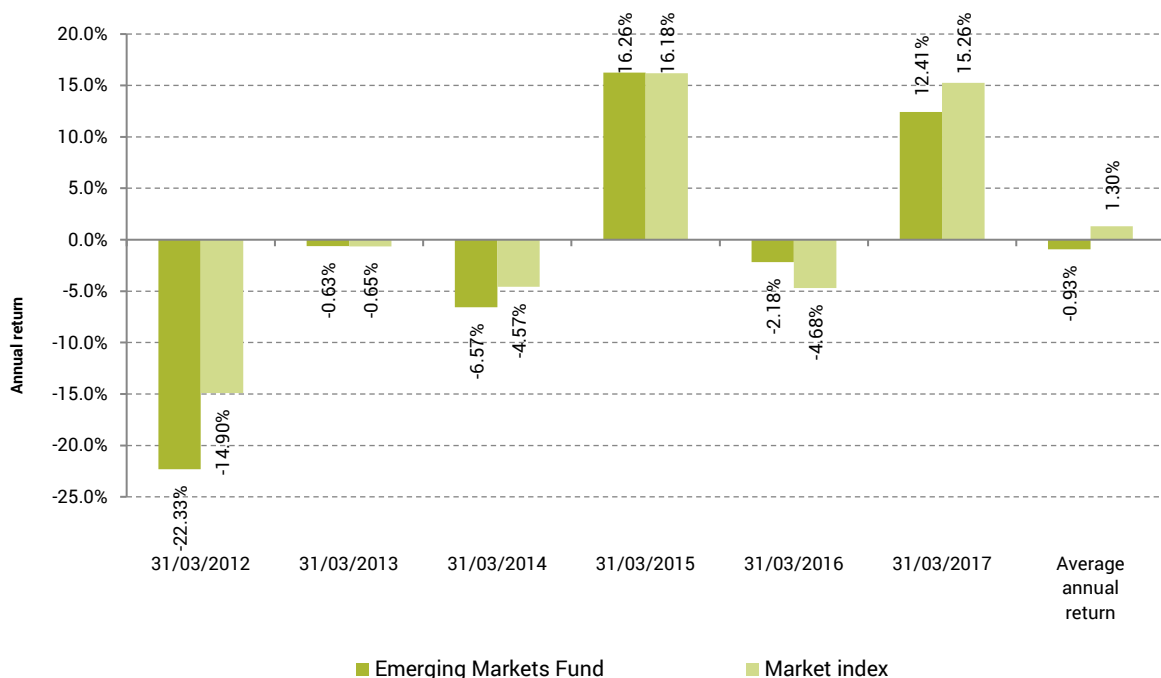

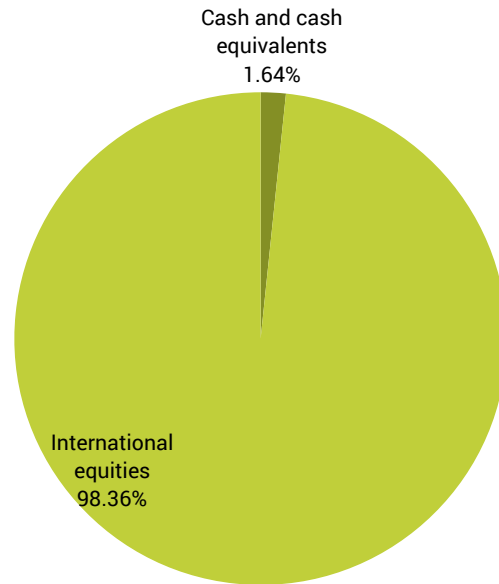
### Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$1,241 (that is 12.41% of her initial \$10,000). Jess paid other charges of \$32<sup>2</sup>. This gives Jess a total return after tax of \$1,209 for the year.

### Notes

- 1 On 9 November 2016, the total management and administration changed to 1.04% per annum. As a result, the total fund charges will be different in the year to 31 March 2018.
- 2 On 9 November 2016, the administration fee changed to \$30 per annum. As a result, the amount set out in the fees table is made up of 4 months of \$2.50 per month (when the administration fee was \$30 per annum) and 8 months of \$2.75 per month (when the administration fee was \$33 per annum).
- 3 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
