This fund update was first made publicly available on 25 July 2018.

What is the purpose of this update?

This document tells you how SuperLife⁸⁰ has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests mostly in growth assets. Designed for investors that want a growth investment option. Negative annual returns may occur once in every 3-5 years on average.

What are the risks of investing?

Risk indicator for SuperLife⁸⁰ 1



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

The market index was changed on 29 June 2018 to ensure the index that the fund is measured against is better aligned to the assets the fund holds.

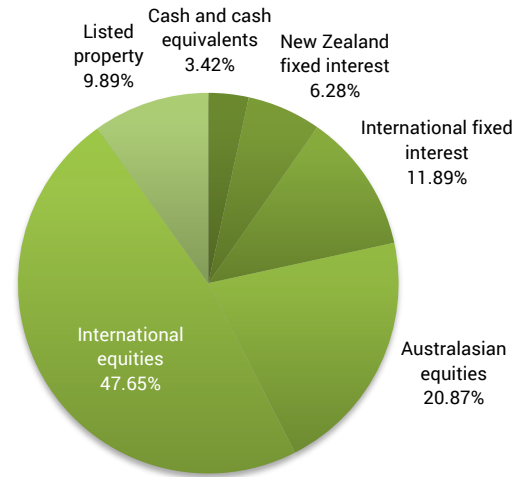
Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$775 (that is 7.75% of her initial \$10,000). Jess paid other charges of \$30. This gives Jess a total return after tax of \$745 for the year.

Notes

- Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years.
