What is the purpose of this update?

What are the risks of investing?

Risk indicator for the Australian Shares Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

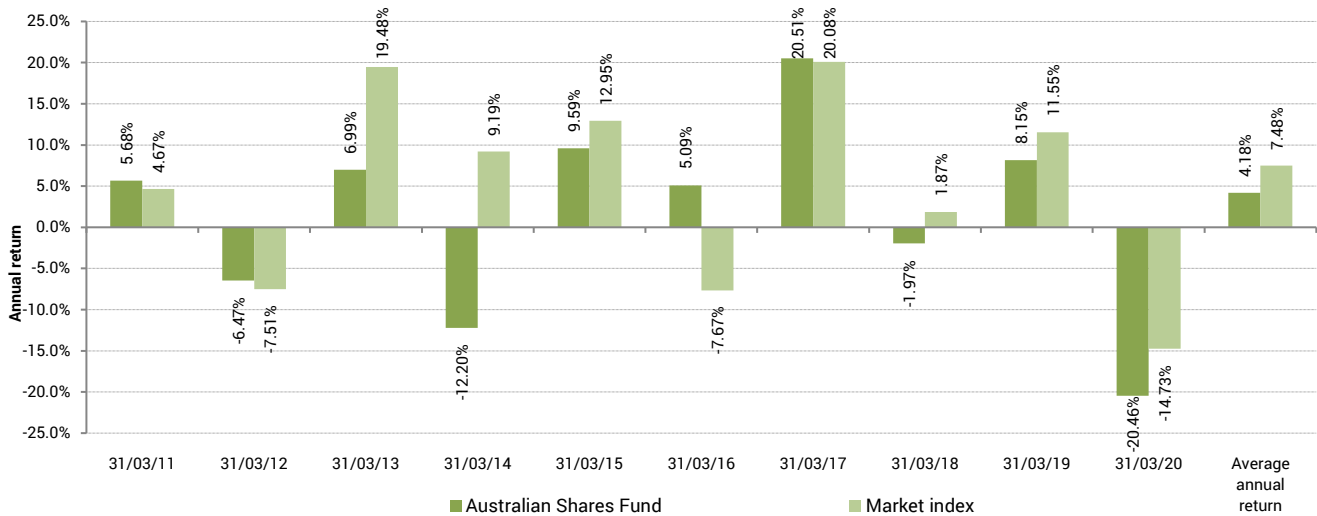
How has the fund performed?

GST is included in the fund charges set out above.

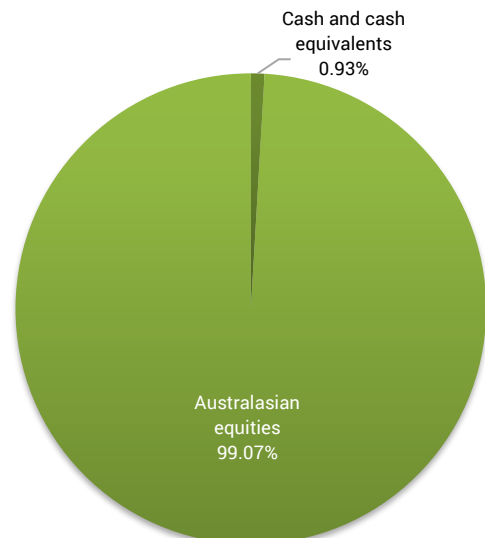
Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$983 (that is -9.83% of her initial \$10,000). Jess paid other charges of \$30. This gives Jess a total loss after tax of -\$1,013 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 75%. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 June 2020, 76.30% of the fund's foreign currency exposure was hedged.
