



# SuperLife KiwiSaver scheme

## SuperLife Default Fund

This is a replacement fund update dated 12 March 2024, which replaces the previous fund update dated 12 February 2024. The market index return data in the "How has the fund performed?" section, including the annual return graph, has been updated to show correct market index returns over the relevant periods.

### Fund update for the quarter ended 31 December 2023

This fund update was first made publicly available on 12 March 2024.

### What is the purpose of this update?

This document tells you how the SuperLife Default Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The SuperLife Default Fund invests in a mix of income and growth assets. Designed for investors that want a balanced investment option. Excludes investments in illegal weapons (cluster munitions, anti-personnel mines and nuclear explosive devices) and fossil fuel production. Negative annual returns may occur once in every 5 – 7 years on average. The fund is a Default KiwiSaver Fund

### What are the risks of investing?

#### Risk indicator for the SuperLife Default Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

### How has the fund performed?

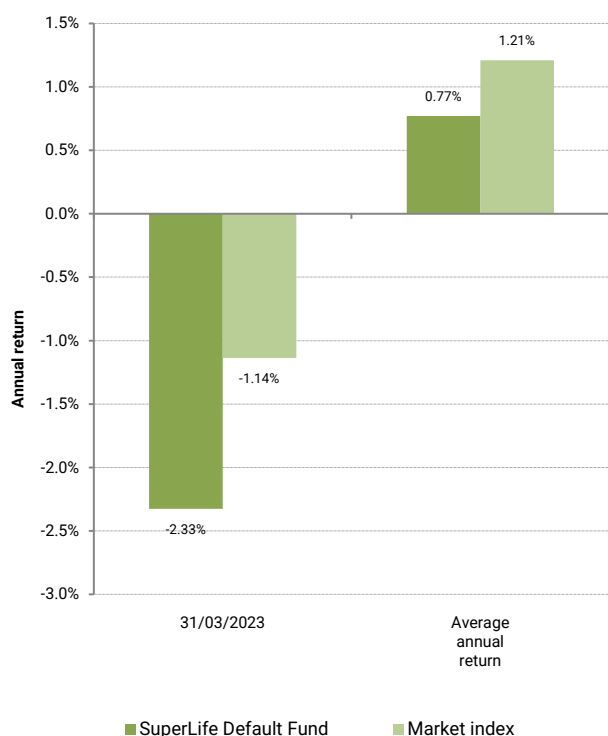

The market index return is a composite of benchmark index returns, weighted for the fund's target investment mix (also known as target asset allocation). The specific benchmark indices used for each asset class are defined in the Statement of Investment Policy and Objectives (SIPO).

On 11 December 2023, the fund's benchmark indices for the international fixed interest, Australasian equities and listed property asset classes were updated to better reflect the investment philosophy of the fund.

## Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2023.

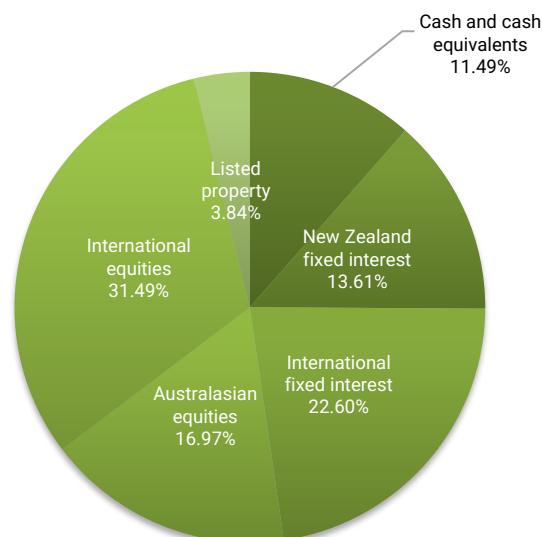
## Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$1215 (that is 12.15% of Jess's initial \$10,000). Jess paid other charges of \$30. This gives Jess a total return after tax of \$1106 for the year.

## Currency hedging

As at 29 December 2023 the fund's exposure to assets denominated in foreign currencies was 58.07%, of which 67.47% was hedged. This means the fund's unhedged foreign currency exposure was 18.89% of the net asset value of the fund. ## Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 2 years and 11 months of market index returns.
- 2 These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
- 3 The SuperLife KiwiSaver scheme has an administration fee of \$30 a year. You do not pay the administration fee if you have all your money invested in the SuperLife Default Fund.
