What is the purpose of this update?

This document tells you how SuperLife^{Income} has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

SuperLife^{Income} invests in income assets. Designed for investors that want to protect the value of their investment. Negative annual returns may occur once in every 10 – 20 years on average.

What are the risks of investing?

Risk indicator for SuperLife^{Income} 1



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

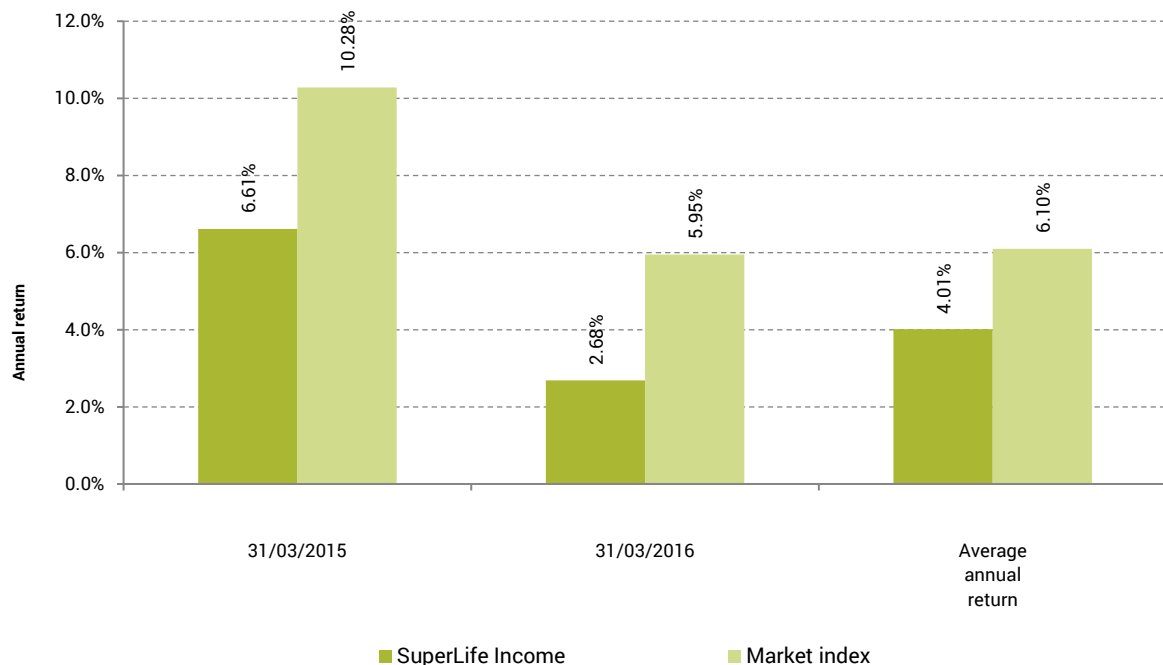

How has the fund performed?

Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2016.

* From 9 November 2016, the total fund charges changed to an estimated 0.51% per annum of the fund's net asset value.

The Scheme has an entry fee. This fee is to meet the costs of transferring your money into the Scheme from a UK pension scheme. It will be calculated as our estimate of those costs and will be agreed with you before we start the transfer process.

Small differences in fees and charges can have a big impact on your investment over the long term.

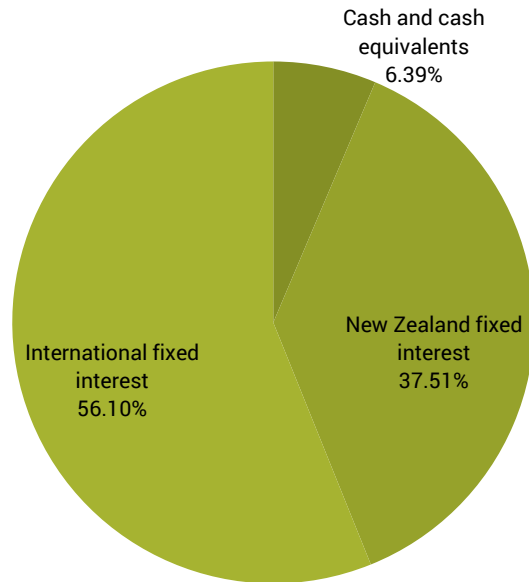
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$301 (that is 3.01% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$241 for the year.
