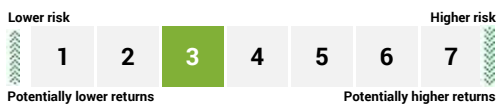
Description of this fund

SuperLife³⁰ invests mostly in income assets. Designed for investors that want a 'conservative' investment option. Negative annual returns may occur once in every 7-10 years on average.

What are the risks of investing?

Risk indicator for SuperLife³⁰



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

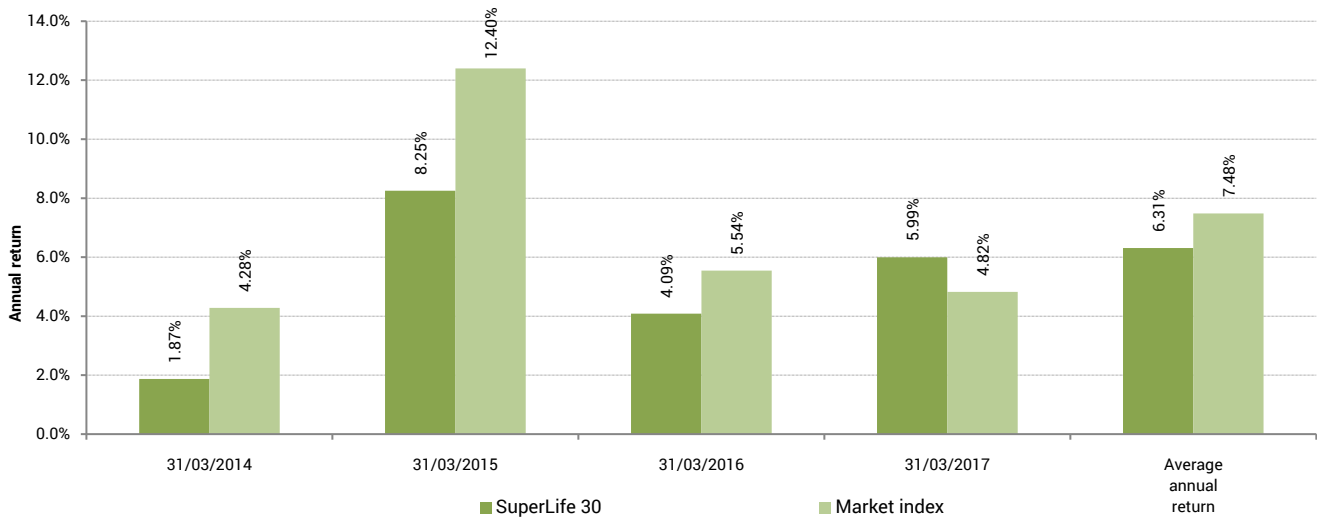

How has the fund performed?

Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2017.

Example of how this applies to an investor

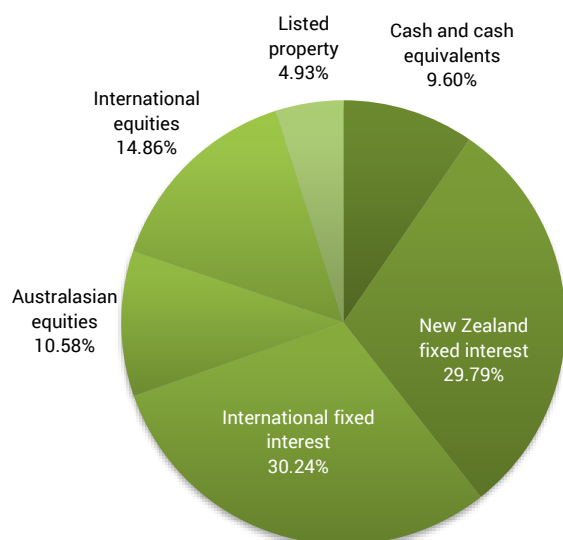
Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$763 (that is 7.63% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$703 for the year.
