### Fund update for the quarter ended 31 December 2020

This fund update was first made publicly available on 16 February 2021.

### What is the purpose of this update?

This document tells you how the S&P/ASX 200 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The S&P/ASX 200 Fund invests in Australian shares and designed to track the return (before tax, fees and other expenses) on the S&P/ASX 200 Index.

### What are the risks of investing?

#### Risk indicator for the S&P/ASX 200 Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

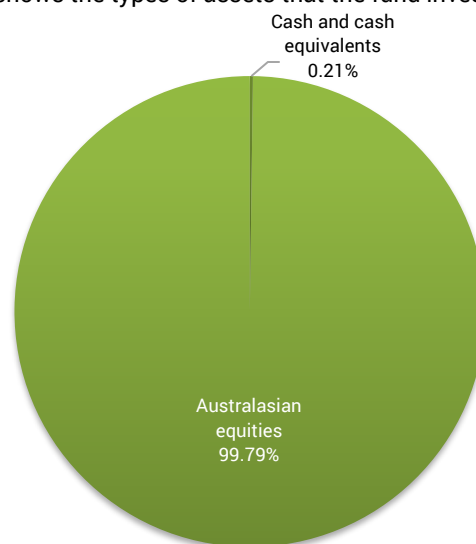
### Example of how this applies to an investor

Jess had \$10,000 in the fund on 15 July 2020 and did not make any further contributions. On 31 December 2020, Jess received a return after fund charges were deducted of \$1135 (that is 11.35% of her initial \$10,000). Jess paid other charges of \$25. This gives Jess a total gain after tax of \$1110 for the 5 months and 15 days.

### Notes

As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 4 years and 7 months of market index returns.
- 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
- 3 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
