What is the purpose of this update?

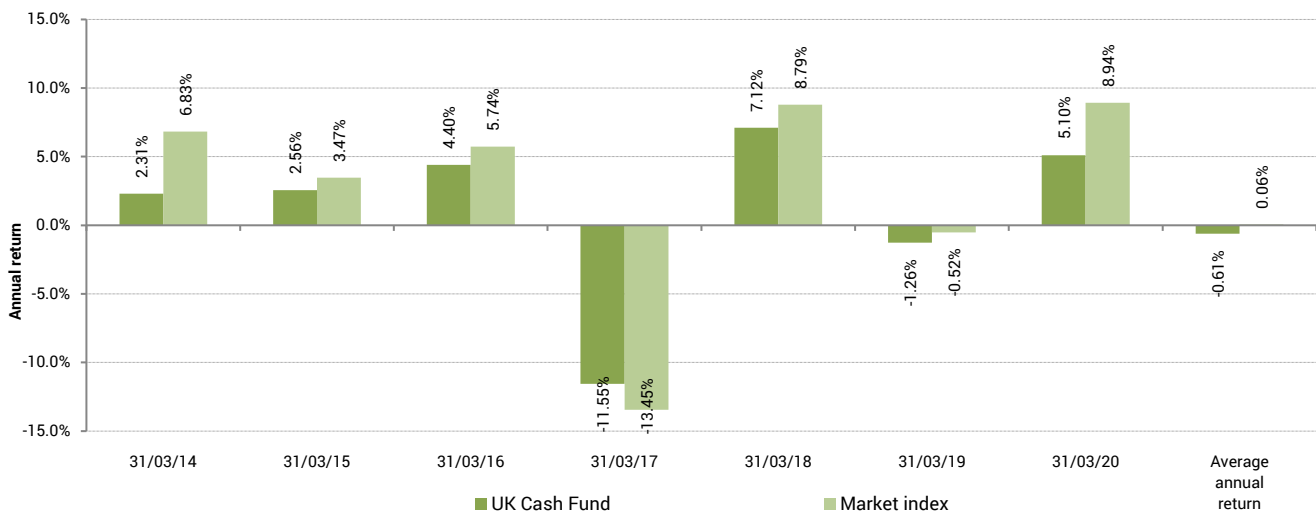

Investors in the UK Cash Fund are charged fund charges. In the year to 31 March 2020 these were:

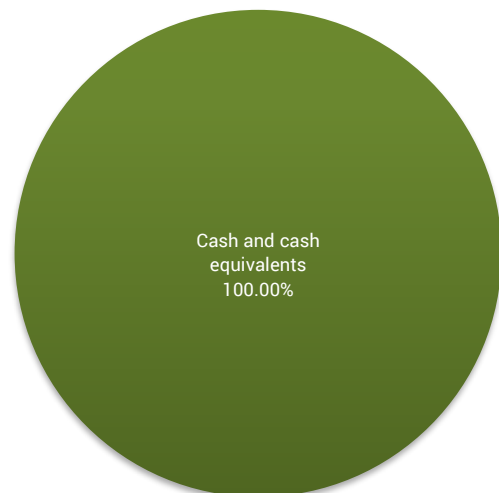
Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$244 (that is -2.44% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$304 for the year.
