### Fund update for the quarter ended 30 June 2020

This fund update was first made publicly available on 28 July 2020.

### What is the purpose of this update?

This document tells you how the NZ Cash Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Invests in New Zealand cash (including term deposits) and designed for investors that want a defensive investment option that reflects the return (before tax, fees and other expenses) on the New Zealand cash market.

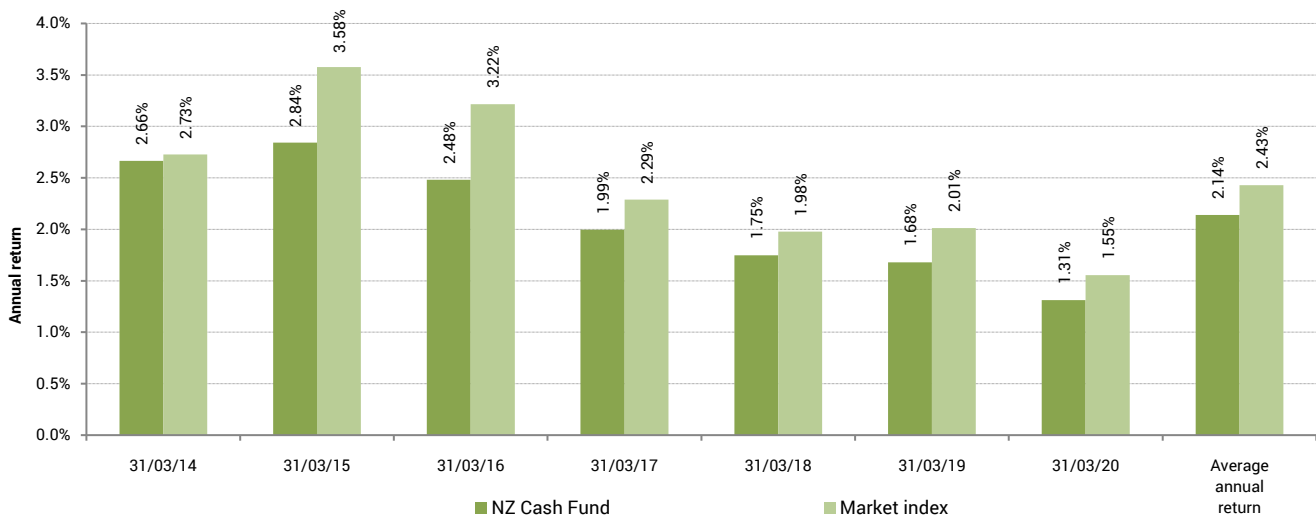
#### Other specific risks

GST is included in the fund charges set out above.

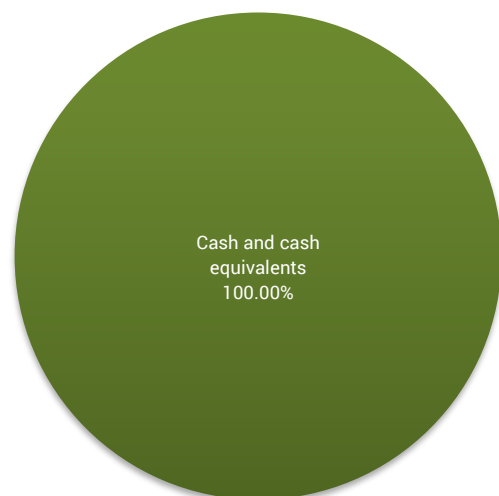
## Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$119 (that is 1.19% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$59 for the year.
