What is the purpose of this update?

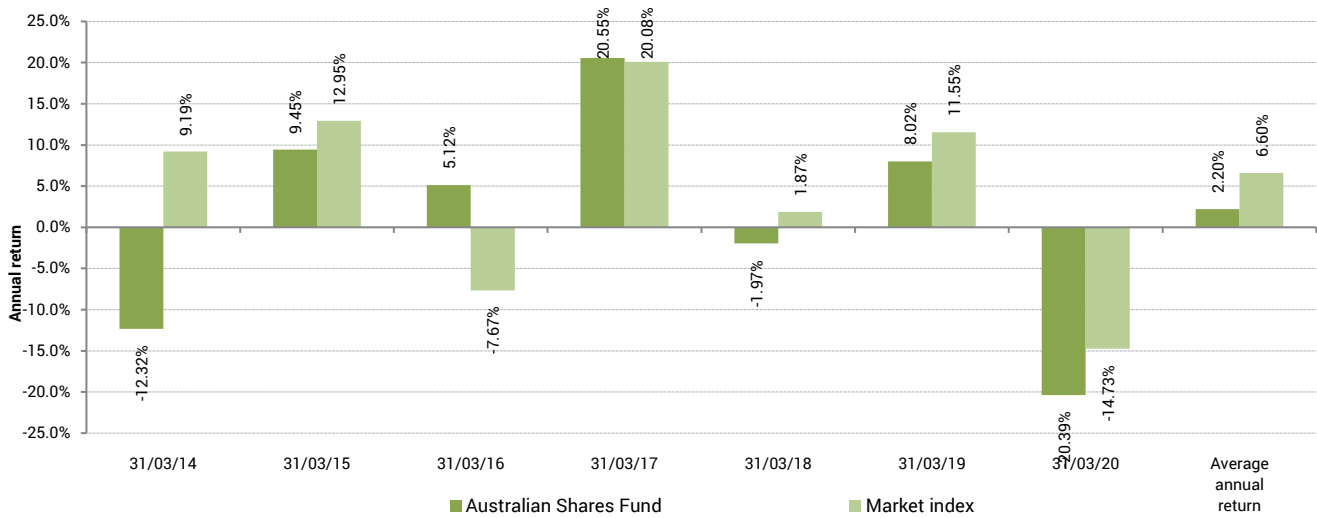
Other specific risks

What fees are investors charged?

Investors in the Australian Shares Fund are charged fund charges. In the year to 31 March 2020 these were:

GST is included in the fund charges set out above.

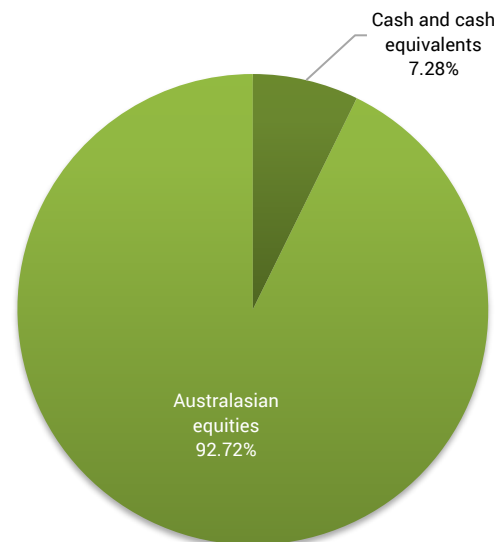
Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$2,039 (that is -20.39% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$2,099 for the year.

The fund's foreign currency exposure may be hedged to the New Zealand dollar, and hedging levels will vary between 0% and 110%. As at 31 March 2020, 72.53% of the fund's foreign currency exposure was hedged.
