What is the purpose of this update?

This document tells you how the Australian Mid Cap Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

Invests in Australian shares and is designed to track the return (before tax, fees and other expenses) of the S&P/ASX Mid Cap 50 Index.

What are the risks of investing?

Risk indicator for the Australian Mid Cap Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

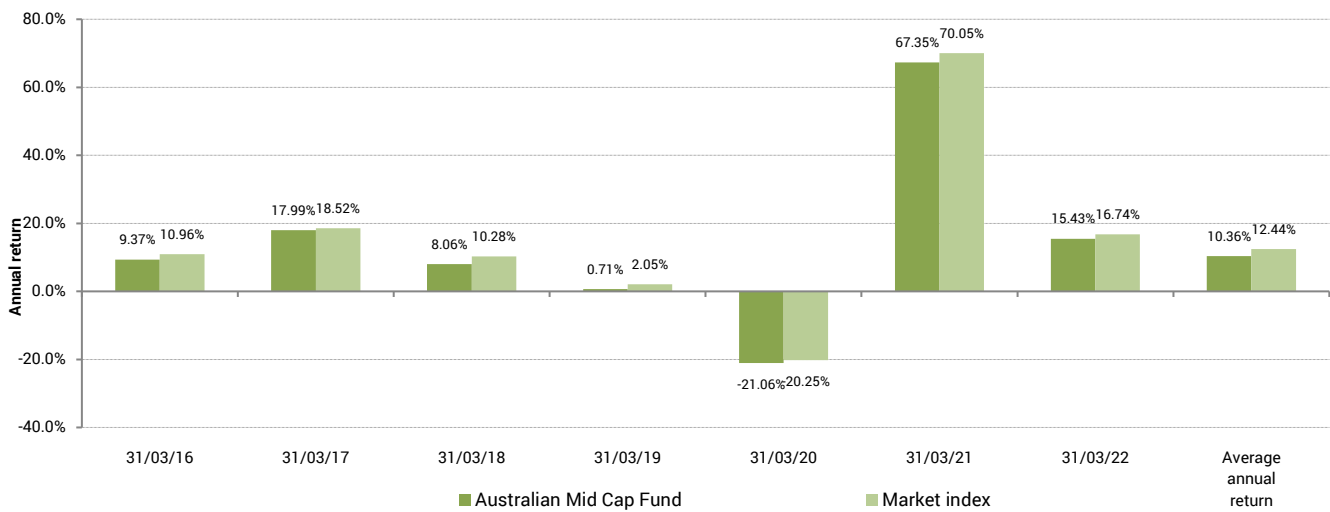
How has the fund performed?

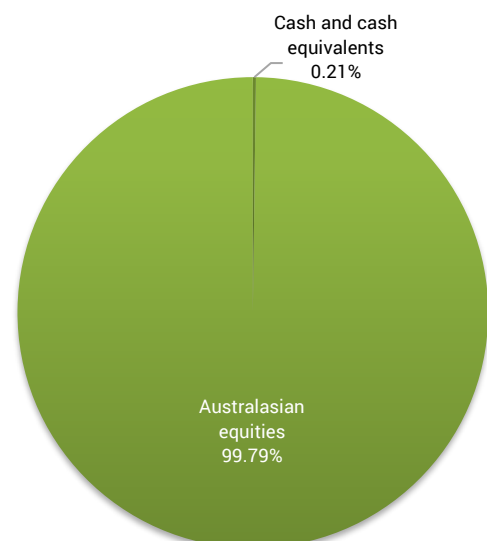
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$73 (that is -0.73% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$133 for the year.

- 1 The fund charges will be increasing by 0.10% per annum of the fund's net asset value, from 12 December 2022
- 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. This may be shown as 0.00% due to rounding.
