### Fund update for the quarter ended 31 December 2021

This fund update was first made publicly available on 14 February 2022.

### What is the purpose of this update?

This document tells you how the Global Aggregate Bond Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The Global Aggregate Bond Fund invests in international bonds and designed to track the return (before tax, fees and other expenses) of the Bloomberg Barclays Global Aggregate Bond Index, 100% hedged to the New Zealand dollar.

### What are the risks of investing?

#### Risk indicator for the Global Aggregate Bond Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

## What fees are investors charged?

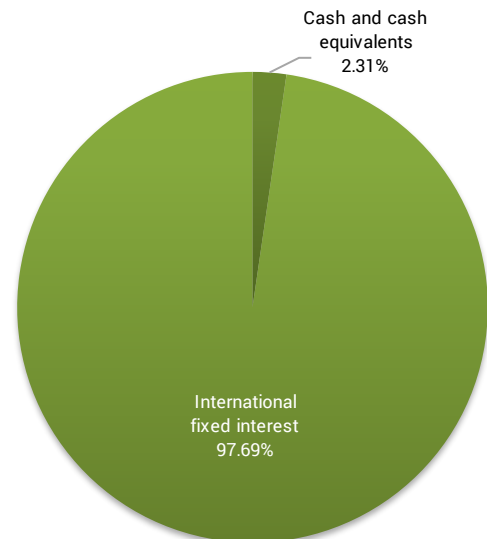
## Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$294 (that is -2.94% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$306 for the year.

## Currency hedging

The fund invests in the Smartshares Global Aggregate Bond ETF which invests in the iShares Core Global Aggregate Bond UCITS ETF NZD Hedged (Acc), which foreign currency exposure is hedged to the New Zealand dollar.

## Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 3 years and 7 months of market index returns.
- 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
- 3 The administration fee in the year to 31 March 2021 is stated net of an income tax deduction that was applied in calculating your PIE tax payable (the deduction was paid to us). On 1 April 2021, we stopped doing this – this means the total fee you will now pay us will be lower.
- 4 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
