# What is the purpose of this update

This document tells you how the SMT Australasian Shares Fund has performed and what fees were charged. The document will help you compare the fund with other funds. # **Description of this fund**

Invests in a portfolio of Australian and New Zealand equities with the aim of providing a gross return (before tax, fees and other expenses) that is consistent with the market index.

# What are the risks of investing?

Risk indicator for the SMT Australasian Shares Fund



An administration fee may apply. If you are an ordinary member, you will pay an administration fee of up to 0.50% of the daily average balance of your account. If you are a specified member, the administration fee you pay (if anything) will depend on what has been agreed with your employer – please consult your employer for more information.

Small differences in fees and charges can have a big impact on your investment over the long term.

# **Example of how this applies to an investor**

Zachary had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Zachary received a return after fund charges were deducted but before tax of \$540 (that is 5.40% of Zachary's initial \$10,000). Zachary also paid \$50 in other charges. This gives Zachary a total return after tax of \$433 for the year.


The amount of other charges you pay depends on whether you are an ordinary member or a specified member. Zachary is an ordinary member and therefore pays an administration fee of 0.50% of the daily average balance of his account. If Zachary were a specified member, the administration fee he pays (if any) depends on what we have agreed with his employer.

The administration fee that Zachary paid for the year is \$50.00. This assumes that the daily average balance of the account is \$10,000. The administration fee could be more or less if the account balance has increased or decreased throughout the year.

### **Currency Hedging**

As at 28 March 2024 the fund's exposure to assets denominated in foreign currencies was 30.08%, of which 50.00% was hedged. This means the fund's unhedged foreign currency exposure was 15.04% of the net asset value of the fund.
