# SuperLife Growth Fund

# What is the purpose of this update?

This document tells you how the SuperLife Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

Invests mostly in growth assets and is designed for investors that want a growth investment option. Negative annual returns may occur once in every 3-5 years on average.




#### **Example of how this applies to an investor**

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted but before tax of \$-458 (that is -4.58% of Jess's initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of \$-479 for the year.

#### **Currency hedging**

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 69.00% of the fund's foreign currency exposure. The actual hedging level can be anywhere in the 0% - 120% range. As at 31 Mar 23, 64.26% of the fund's foreign currency exposure was hedged. - 2 The 'other' category refers to an investment in infrastructure. The underlying investments are infrastructure securities listed in developed countries.
