What is the purpose of this update?

This document tells you how the Global Property Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in international property and is designed to reflect the return (before tax, fees and other expenses) on New Zealand and international property markets.

Total value of the fund: \$76,074,160

The date the fund started: 28 October 2016

What are the risks of investing?

Risk indicator for the Global Property Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?

This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 March 2024.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$870 (that is 8.70% of Jess's initial \$10,000). Jess also paid \$12 in other charges. This gives Jess a total return after tax of \$767 for the year.

Currency hedging

As at March 28 2024 the fund's exposure to assets denominated in foreign currencies was 75.63%, of which 98.25% was hedged. This means the fund's unhedged foreign currency exposure was 1.33% of the net asset value of the fund.
