## Ethica Fund

This is a replacement fund update dated 21 December 2023, which replaces the previous fund update dated 31 July 2023. The market index return data in the "How has the fund performed?" section, including the annual return graph, has been updated to show correct market index returns over the relevant periods.

### Fund update for the quarter ended 30 June 2023

This fund update was first made publicly available on 21 December 2023.

### What is the purpose of this update?

This document tells you how the Ethica Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Designed for investors that want a balance between stability of returns and growth of their investment over the long term. Provides exposure to a diverse selection of global companies and income assets that align with our Responsible Investment Policy. We exclude assets that do not meet our socially responsible investment standards, and increase or decrease exposure to companies based on their environmental, social and governance (ESG) factors.

### What are the risks of investing?

#### Risk indicator for the Ethica Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

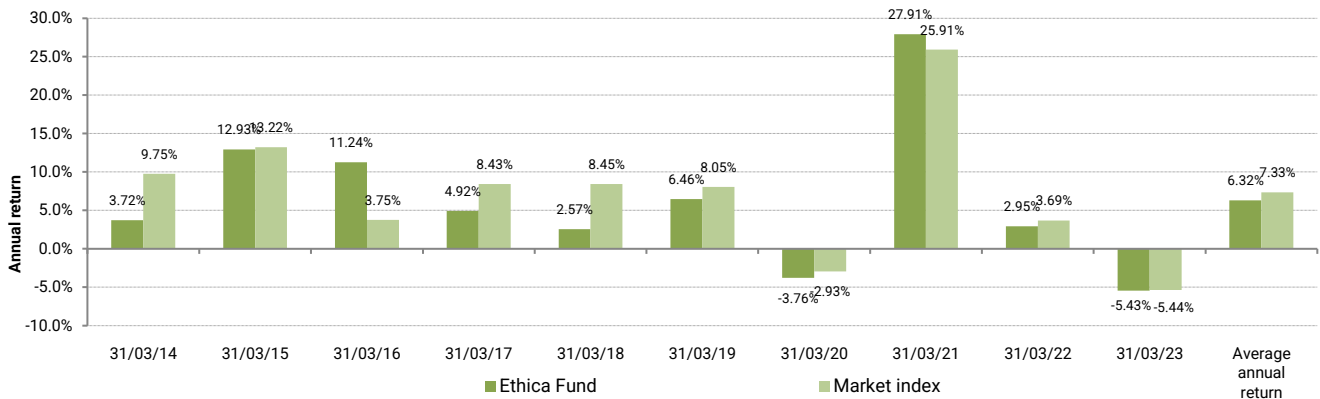
### How has the fund performed?

## Annual return graph

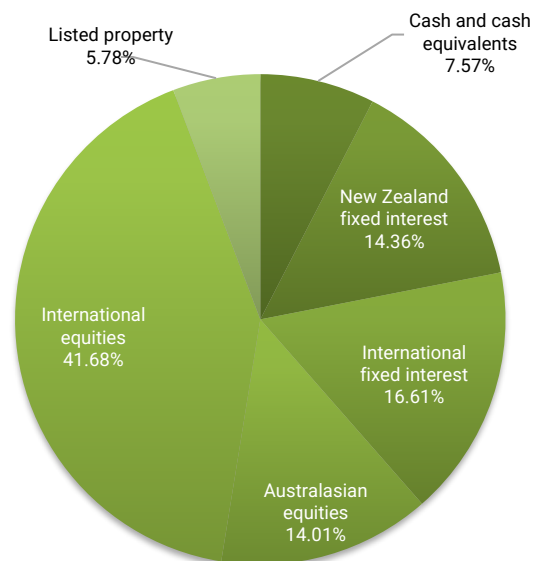
## Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$683 (that is 6.83% of Jess's initial \$10,000). Jess paid other charges of \$30. This gives Jess a total return after tax of \$570 for the year.

## Currency hedging

As at 30 June 2023 the fund's exposure to assets denominated in foreign currencies was 57.98%, of which 78.01% was hedged. This means the fund's unhedged foreign currency exposure was 12.75% of the net asset value of the fund. - 1 These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
