Fund update for the quarter ended 31 March 2024

This fund update was first made publicly available on 30 April 2024.

What is the purpose of this update?

This document tells you how the NZ Cash Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in New Zealand cash (including term deposits) and is designed to provide a return (before tax, fees and other expenses) that outperforms the S&P/NZX Bank Bill 90-Day Index over rolling one-year periods.

Total value of the fund: \$67,027,956

Number of investors in the fund: 3,545

The date the fund started: 8 October 2007

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$433 (that is 4.33% of Jess's initial \$10,000). Jess also paid \$30 in other charges. This gives Jess a total return after tax of \$340 for the year.
