Fund update for the quarter ended 31 March 2024

This fund update was first made publicly available on 30 April 2024.

What is the purpose of this update?

This document tells you how the Overseas Shares (Currency Hedged) Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in international shares and is designed to reflect the return (before tax, fees and other expenses) on international share markets of developed economies, hedged to the New Zealand dollar.

Total value of the fund: \$25,651,431

Number of investors in the fund: 1,890

The date the fund started: 24 October 2007

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$2665 (that is 26.65% of Jess's initial \$10,000). Jess also paid \$30 in other charges. This gives Jess a total return after tax of \$2628 for the year.

Currency hedging

As at 28 March 2024 the fund's exposure to assets denominated in foreign currencies was 101.37%, of which 97.04% was hedged. This means the fund's unhedged foreign currency exposure was 3.00% of the net asset value of the fund. Notes

These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
