What is the purpose of this update?

This document tells you how the Overseas Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. 

Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$3050 (that is 30.50% of Jess's initial \$10,000). Jess also paid \$30 in other charges. This gives Jess a total return after tax of \$2887 for the year.
