What is the purpose of this update?

This document tells you how the Global Property Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in international property and is designed to reflect the return (before tax, fees and other expenses) on New Zealand and international property markets.

The market index return is a composite of benchmark index returns, weighted for the fund's target investment mix (also known as target asset allocation). The specific benchmark indices used for each asset class are defined in the Statement of Investment Policy and Objectives (SIPO). The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


Note that even the lowest category does not mean a riskfree investment, and there are other risks that are not captured by this rating.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$851 (that is 8.51% of Jess's initial \$10,000). Jess also paid \$60 in other charges. This gives Jess a total return after tax of \$710 for the year.

Currency hedging

As at 28 March 2024 the fund's exposure to assets denominated in foreign currencies was 75.63%, of which 98.25% was hedged. This means the fund's unhedged foreign currency exposure was 1.33% of the net asset value of the fund. Notes

1 These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
