

SuperLife Invest ANNUAL REPORT FOR THE YEAR TO 31 MARCH 2022

Details of Scheme

This is the annual report for SuperLife Invest (**Scheme**) for the year to 31 March 2022. The Scheme is a registered Managed Investment Scheme.

The Scheme's manager is Smartshares Limited (**Smartshares**), which is a wholly owned subsidiary of NZX Limited. The Scheme's supervisor is Public Trust.

The latest product disclosure statement for the Scheme is dated 25 August 2021. The Scheme is open for applications.

The latest fund updates for the Scheme are dated 3 May 2022.

The latest financial statements for the Scheme for the year to 31 March 2022, including the auditor's reports relating to those statements, have been lodged with the Registrar of Financial Service Providers.
