Stick to your goal

Transition of investment management and administration to Smartshares Limited (Smartshares)

Smartshares is the manager of the ASB Superannuation Master Trust (Scheme) and has delegated certain investment management and administration functions to ASB Group Investments Limited (ASBGI) for a transitional period.

These functions will be transitioning to Smartshares and as part of that process you will see that the Scheme will be renamed to be the SuperLife Superannuation Master Trust. There will be no changes to your fund choice or employer contributions and all of the details of your investment will remain how you have set them.
