
# Description of this fund

To provide exposure to a portfolio of investment grade short term deposits and fixed interest investments with New Zealand registered banks. The number of years with negative returns are generally expected to be less than other funds in the ASB Superannuation Master Trust. There is a focus on cost effective management. The ASB NZ Cash Fund invests in a target investment mix of 100% income assets.

# What are the risks of investing?

#### Risk indicator for ASB NZ Cash Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



# Annual return graph

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). See the ASB Superannuation Master Trust PDS for more information about those fees.

An administration fee may apply. If you are an ordinary member, you will pay an administration fee of 0.50% of the daily average balance of your account. If you are a specified member, the administration fee you pay (if anything) will depend on what has been agreed with your employer – please consult your employer for more information.

Small differences in fees and charges can have a big impact on your investment over the long term.

# Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$300.00 (that is 3.00% of his initial \$10,000). Jason also paid \$50.75 in other charges.\* This gives Jason a total return after tax of \$249.25 for the year.

\*The amount of other charges you pay depends on whether you are an ordinary member or a specified member. Jason is an ordinary member and therefore pays an administration fee of 0.50% of the daily average balance of his account.† If Jason were a specified member, the administration fee he pays (if any) depends on what we have agreed with his employer.

† The administration fee that Jason paid for the year is \$50.75. This assumes that the daily average balance of his account is \$10,150.00.
