What is the purpose of this update?

This document tells you how the ASB NZ Fixed Interest Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

To provide exposure to a portfolio of investment grade New Zealand fixed interest investments. The number of years with negative returns are generally expected to be less than for funds in the ASB Superannuation Master Trust which predominantly invest in growth assets. There is a focus on cost effective management. The ASB NZ Fixed Interest Fund invests in a target investment mix of 100% income assets.

What are the risks of investing?

Risk indicator for ASB NZ Fixed Interest Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). See the ASB Superannuation Master Trust PDS for more information about those fees.

An administration fee may apply. If you are an ordinary member, you will pay an administration fee of 0.50% of the daily average balance of your account. If you are a specified member, the administration fee you pay (if anything) will depend on what has been agreed with your employer – please consult your employer for more information.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$7.00 (that is 0.07% of his initial \$10,000). Jason also paid \$50.02 in other charges.* This gives Jason a total loss after tax of \$-43.02 for the year.

*The amount of other charges you pay depends on whether you are an ordinary member or a specified member. Jason is an ordinary member and therefore pays an administration fee of 0.50% of the daily average balance of his account.† If Jason were a specified member, the administration fee he pays (if any) depends on what we have agreed with his employer.

† The administration fee that Jason paid for the year is \$50.02. This assumes that the daily average balance of his account is \$10,003.50.
