This fund update was first made publicly available on 8 April 2024

This is a replacement fund update dated 8 April 2024, which replaces the previous fund update dated 30 October 2023. The market index return data in the "How has the fund performed?" section, including the annual return graph, has been updated to show correct market index returns over the relevant periods.

What is the purpose of this update

This document tells you how the SMT Australasian Shares Fund has performed and what fees were charged. The document will help you compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in a portfolio of Australian and New Zealand equities with the aim of providing a gross return (before tax, fees and other expenses) that is consistent with the market index.

What are the risks of investing?

Risk indicator for the SMT Australasian Shares Fund



<u>register.companiesoffice.govt.nz</u>. On 28 August 2023, Smartshares Limited replaced ASB Group Investments Limited as the investment manager of the fund. As a result, the fund's market index above replaced the previous composite index consisting of the S&P/NZX 50 Gross with Imputation Index (70%) and S&P/ASX 200 Accumulation Index (100% hedged) (30%).

Annual Return Graph

An administration fee may apply. If you are an ordinary member, you will pay an administration fee of up to 0.50% of the daily average balance of your account. If you are a specified member, the administration fee you pay (if anything) will depend on what has been agreed with your employer – please consult your employer for more information.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Zachary had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Zachary received a return after fund charges were deducted but before tax of \$572 (that is 5.72% of their initial \$10,000). Zachary paid other charges of \$50. This gives Zachary a total return after tax of \$402 for the year.


The amount of other charges you pay depends on whether you are an ordinary member or a specified member. Zachary is an ordinary member and therefore pays an administration fee of 0.50% of the daily average balance of his account. If Zachary were a specified member, the administration fee he pays (if any) depends on what we have agreed with his employer.

The administration fee that Zachary paid for the year is \$50.00. This assumes that the daily average balance of the account is \$10,000. The administration fee could be more or less if the account balance has increased or decreased throughout the year.

Currency Hedging

As at 29 September 23 the fund's exposure to assets denominated in foreign currencies was 30.87%, of which 50.00% was hedged. This means the fund's unhedged foreign currency exposure was 15.43% of the net asset value of the fund.
