
Description of this fund

Invests in a portfolio of investment grade New Zealand fixed interest investments with the aim of providing a gross return (before tax, fees and other expenses) that is consistent with the market index.

What are the risks of investing?

Risk indicator for the SMT NZ Fixed Interest Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the fund performed?

The market index return is based on the annual return of the S&P/NZX A-Grade Corporate Bond Index (50%) and S&P/NZX NZ Government Bond Index (50%). On 28 August 2023, the weighting of each underlying index was changed from 40%/60%, to 50%/50% respectively. This change reflects Smartshares Limited replacing ASB Group Investments Limited as the fund's investment manager. An administration fee may apply. If you are an ordinary member, you will pay an administration fee of up to 0.50% of the daily average balance of your account. If you are a specified member, the administration fee you pay (if anything) will depend on what has been agreed with your employer – please consult your employer for more information.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Zachary had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Zachary received a return after fund charges were deducted but before tax of \$47 (that is 0.47% of their initial \$10,000). Zachary paid other charges of \$50. This gives Zachary a total loss after tax of \$-24 for the year.


The amount of other charges you pay depends on whether you are an ordinary member or a specified member. Zachary is an ordinary member and therefore pays an administration fee of 0.50% of the daily average balance of his account. If Zachary were a specified member, the administration fee he pays (if any) depends on what we have agreed with his employer.

The administration fee that Zachary paid for the year is \$50.00. This assumes that the daily average balance of the account is \$10,000. The administration fee could be more or less if the account balance has increased or decreased throughout the year.
