### What is the purpose of this update

This document tells you how the SMT Growth Fund has performed and what fees were charged. The document will help you compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Aims to provide high total returns allowing for large movements of value up and down. The number of years with negative annual returns are generally expected to be the highest of the Diversified Funds.

### What are the risks of investing?

#### Risk indicator for the SMT Growth Fund



## How has the fund performed?

### Annual return graph



This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 December 2025.

## What fees are investors charged?

An administration fee may apply. If you are an ordinary member, you will pay an administration fee of up to 0.50% of the daily average balance of your account. If you are a specified member, the administration fee you pay (if anything) will depend on what has been agreed with your employer – please consult your employer for more information.

Small differences in fees and charges can have a big impact on your investment over the long term.

## Example of how this applies to an investor

Zachary had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Zachary received a return after fund charges were deducted but before tax of \$1,170 (that is 11.70% of Zachary's initial \$10,000). Zachary also paid \$50 in other charges. This gives Zachary a total return after tax of \$1,014 for the year.


The amount of other charges you pay depends on whether you are an ordinary member or a specified member. Zachary is an ordinary member and therefore pays an administration fee of 0.50% of the daily average balance of his account. If Zachary were a specified member, the administration fee he pays (if any) depends on what we have agreed with his employer.

The administration fee that Zachary paid for the year is \$50.00. This assumes that the daily average balance of the account is \$10,000. The administration fee could be more or less if the account balance has increased or decreased throughout the year.

## Currency hedging

As at 31 December 2025 the fund's exposure to assets denominated in foreign currencies was 77.81%, of which 55.80% was hedged. This means the fund's unhedged foreign currency exposure was 34.39% of the net asset value of the fund. ## Notes

- 1 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. This may be shown as 0.00% due to rounding.
- 2 The 'other' category refers to an investment in infrastructure. The underlying investments are infrastructure securities listed in developed countries.
- 3 John Raby was appointed as a director with effect from 1 October 2025, replacing Guy Elliffe who ceased to be a director on 31 December 2025. Lisa Turnbull was appointed as Chief Executive Officer of Smart with effect from 16 October 2025
