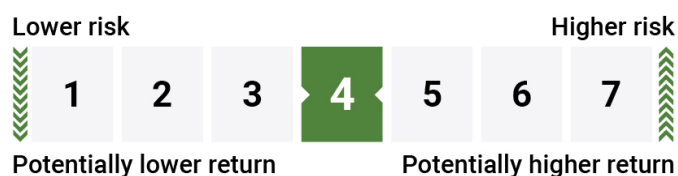
Description of this fund

Aims to provide moderate to high total returns allowing for moderate to high movements of value up and down. The number of years with negative returns are generally expected to be higher than the Moderate Fund but lower than the Growth Fund.

What are the risks of investing?

Risk indicator for the SuperLife Superannuation Master Trust Balanced Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

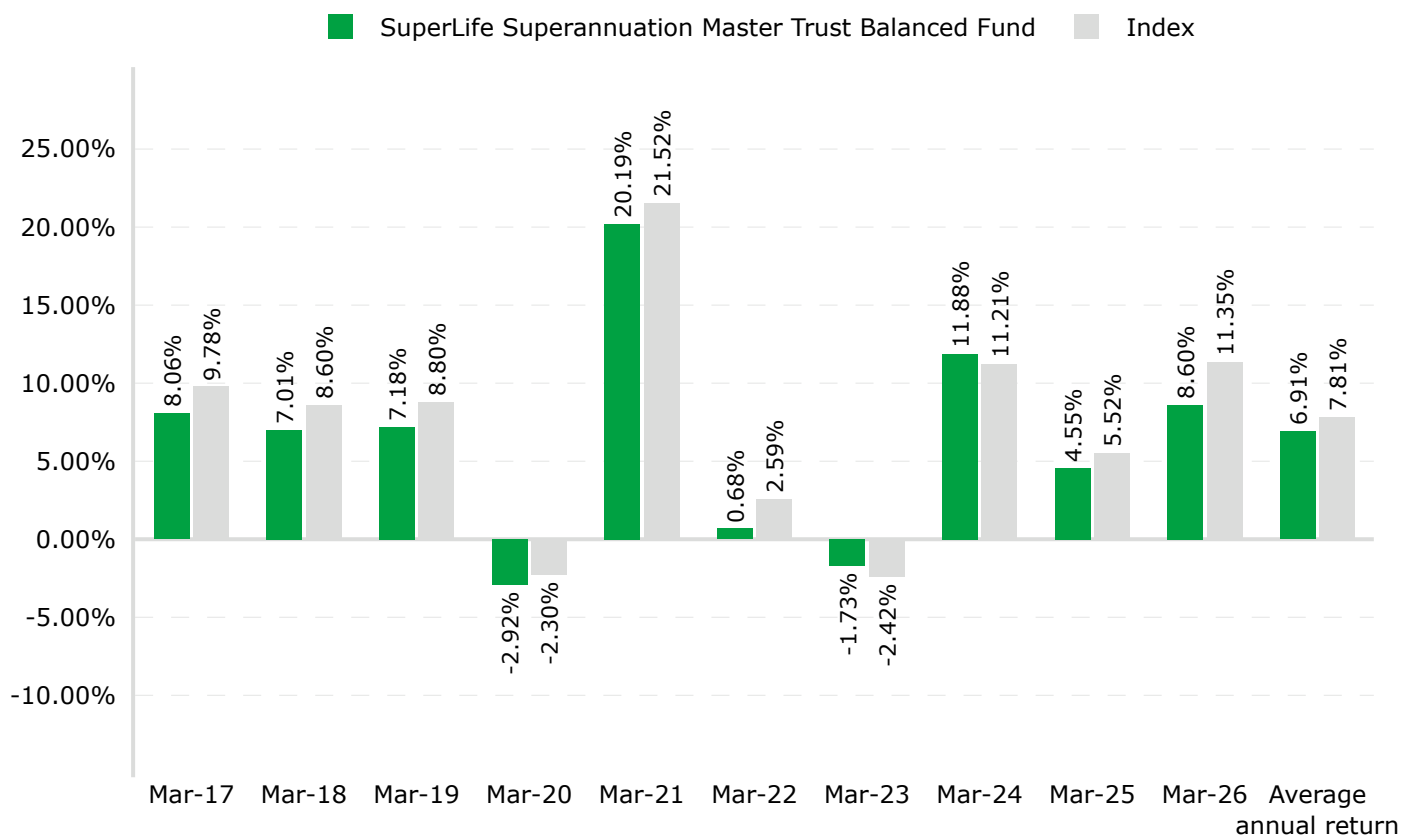

How has the fund performed?

Annual return graph



This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 30 June 2026.

What fees are investors charged?

Investors in the SuperLife Superannuation Master Trust Balanced Fund are charged fund charges. In the year to 31 March 2026 these were:

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). See the Product Disclosure Statement for the SuperLife Superannuation Master Trust for more information about those fees.

An administration fee may apply. If you are an ordinary member, you will pay an administration fee of up to 0.50% of the daily average balance of your account. If you are a specified member, the administration fee you pay (if anything) will depend on what has been agreed with your employer – please consult your employer for more information.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$1,418 (that is 14.18% of Jess's initial \$10,000). Jess also paid \$50.00 in other charges. This gives Jess a total return after tax of \$1,322 for the year.

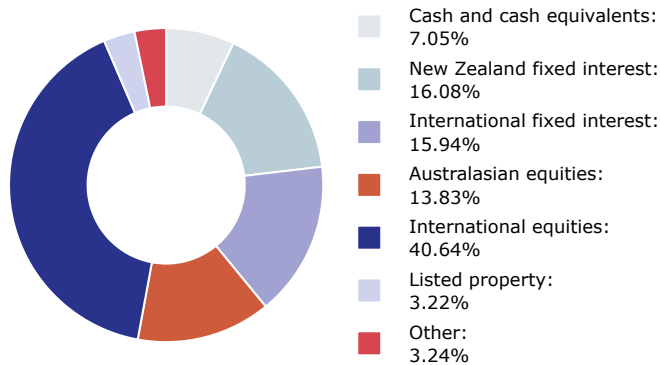
The amount of other charges you pay depends on whether you are an ordinary member or a specified member. Jess is an ordinary member and therefore pays an administration fee of 0.50% of the daily average balance of his account. If Jess were a specified member, the administration fee he pays (if any) depends on what we have agreed with his employer.

The administration fee that Jess paid for the year is \$50.00. This assumes that the daily average balance of the account is \$10,000. The administration fee could be more or less if the account balance has increased or decreased throughout the year.

Currency hedging

As at 30 June 2026 the fund's exposure to assets denominated in foreign currencies was 68.23%, of which 63.22% was hedged. This means the fund's unhedged foreign currency exposure was 25.09% of the net asset value of the fund.
