What is the purpose of this update?

This document tells you how the Overseas Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Overseas Shares Fund is designed to provide a return (after tax, fees and other expenses) that reflects the aftertax return on the international share markets of developed economies.

What are the risks of investing?

Risk indicator for the Overseas Shares Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a riskfree investment, and there are other risks that are not captured by this rating.

While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

Other specific risks

There are other risks that may increase the risk to returns for investors, which are not reflected in the risk indicator. These risks include investment management risk. In particular, while SuperLife Invest's philosophy is that a passive approach to investing will deliver better long-term results, we make some active management decisions. There is a risk that this may result in the fund achieving a return that is lower than its investment objective.




Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$324 (that is 3.24% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$312 for the year.

Material changes

There have been no material changes to the nature of the scheme, the investment objectives and strategy of the fund, or the management of the scheme over the quarter ended 30 September 2019.

Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 2 years and 1 month of market index returns.
- The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
