### Fund update for the quarter ended 31 December 2020

This fund update was first made publicly available on 16 February 2021.

### What is the purpose of this update?

This document tells you how the NZ Top 10 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Invests in New Zealand shares and designed to track the return (before tax, fees and other expenses) on the S&P/NZX 10 Index.

### What are the risks of investing?

#### Risk indicator for the NZ Top 10 Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

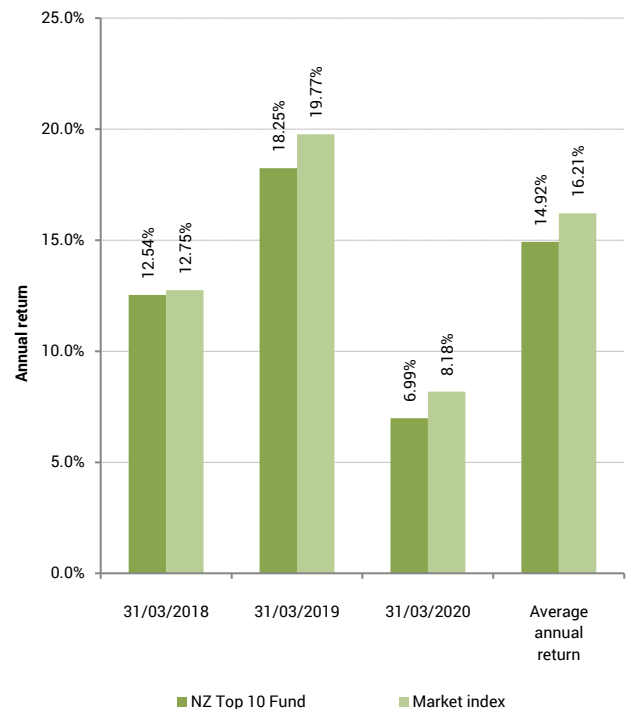

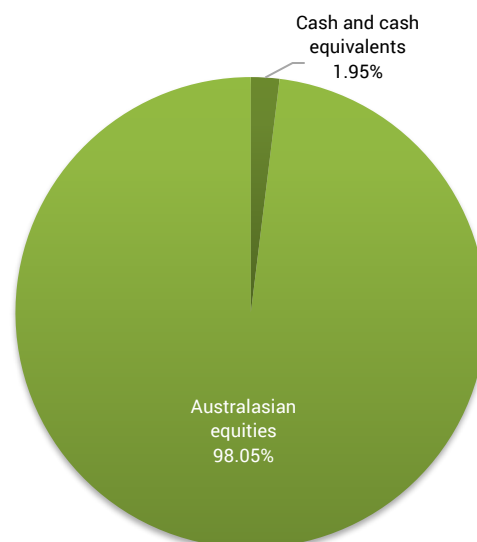
### Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$1,734 (that is 17.34% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$1,722 for the year.

## Material changes

There have been no material changes to the nature of SuperLife Invest, the investment objectives and strategy of the fund, or the management of the scheme over the quarter ended 31 December 2020.

## Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 10 months of market index returns.
- 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
- 3 The administration fee is stated net of an income tax deduction applied in calculating your PIE tax payable (the deduction is paid to us). The relevant gross fee is calculated using your PIR.
