Fund update for the quarter ended 31 March 2020

This fund update was first made publicly available on 1 May 2020.

What is the purpose of this update?

This document tells you how the Overseas Shares (Currency Hedged) Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Overseas Shares (Currency Hedged) Fund is designed to provide a return (after tax, fees and other expenses) that reflects the after-tax return on the international share markets of developed economies. This fund is hedged against the NZ dollar.

Total value of the fund: \$99,628,563

The date the fund started: 28 October 2016

What are the risks of investing?

Risk indicator for the Overseas Shares (Currency Hedged) Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the fund performed?


Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$1,428 (that is - 14.28% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$1,440 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar, and hedging levels will vary between 90% and 110%. As at 31 March 2020, 99.05% of the fund's foreign currency exposure was hedged.

Material changes

There have been no material changes to the nature of SuperLife Invest, the investment objectives and strategy of the fund, or the management of the scheme over the quarter ended 31 March 2020.

Notes
