What is the purpose of this update?

This document tells you how the NZ Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in New Zealand shares and designed to reflect the return (before tax, fees and other expenses) on the New Zealand share market.

What are the risks of investing?

Risk indicator for the NZ Shares Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?


Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of -\$99 (that is - 0.99% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$111 for the year.

Material changes

There have been no material changes to the nature of SuperLife Invest, the investment objectives and strategy of the fund, or the management of the scheme over the quarter ended 30 September 2020.

Notes

- Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 1 year and 1 month of market index returns.
- The administration fee is stated net of an income tax deduction applied in calculating your PIE tax payable (the deduction is paid to us). The relevant gross fee is calculated using your PIR.
