What is the purpose of this update?

This document tells you how the Overseas Bonds Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

Risk indicator for the Overseas Bonds Fund






Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$298 (that is -2.98% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$310 for the year.
