What is the purpose of this update?

This document tells you how the Ethica Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Designed for investors that want a balance between stability of returns and growth of their investment over the long term. Provides exposure to a diverse selection of global companies and income assets that align with our Responsible Investment Policy. We exclude assets that do not meet our socially responsible investment standards, and increase or decrease exposure to companies based on their environmental, social and governance (ESG) factors.

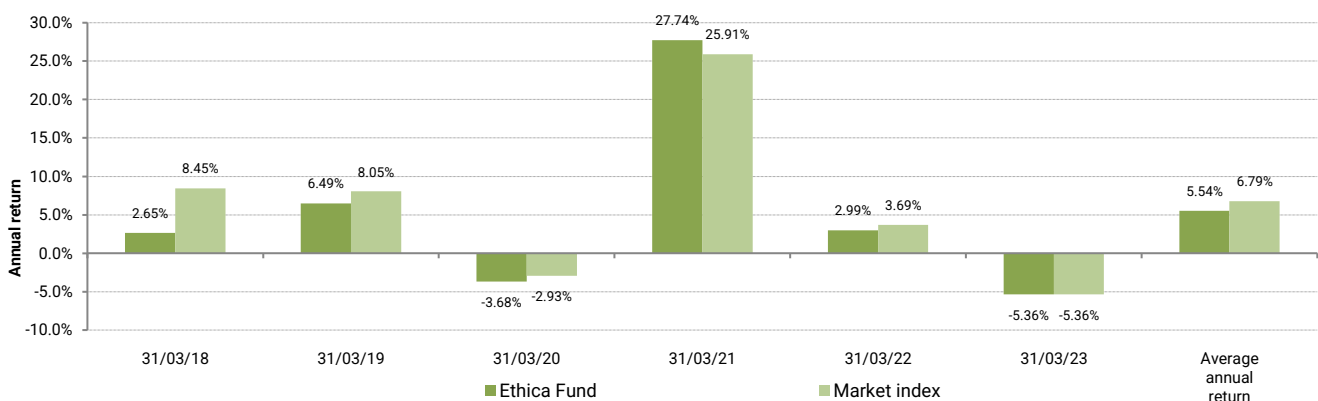
What are the risks of investing?

Risk indicator for the Ethica Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

The market index return is a composite of benchmark index returns, weighted for the fund's target investment mix (also known as target asset allocation). The specific benchmark indices used for each asset class are defined in the Statement of Investment Policy and Objectives (SIPO). On 11 December 2023, the fund's benchmark indices for the international equities and listed property asset classes were updated to better reflect the investment philosophy of the fund.

What fees are investors charged?

Investors in the Ethica Fund are charged fund charges. In the year to 31 March 2023 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$1276 (that is 12.76% of Jess's initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$1125 for the year.

Currency hedging

As at December 29 2023 the fund's exposure to assets denominated in foreign currencies was 68.73%, of which 67.72% was hedged. This means the fund's unhedged foreign currency exposure was 22.19% of the net asset value of the fund.
