The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets




Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$715 (that is 7.15% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$703 for the year.

Notes

These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
