What is the purpose of this update?




Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$1,659 (that is 16.59% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$1,647 for the year.

Notes
