### What is the purpose of this update?

This document tells you how the Australian Resources Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ### **Description of this fund**

Invests in Australian shares and is designed to track the return (before tax, fees and other expenses) of the S&P/ASX 200 Resources Index.

# What are the risks of investing?


## How has the fund performed?


## **Example of how this applies to an investor**

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted but before tax of -\$217 (that is -2.17% of Jess's initial \$10,000). Jess also paid \$12 in other charges. This gives Jess a total loss after tax of -\$384 for the year.
