What is the purpose of this update?

Description of this fund

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets

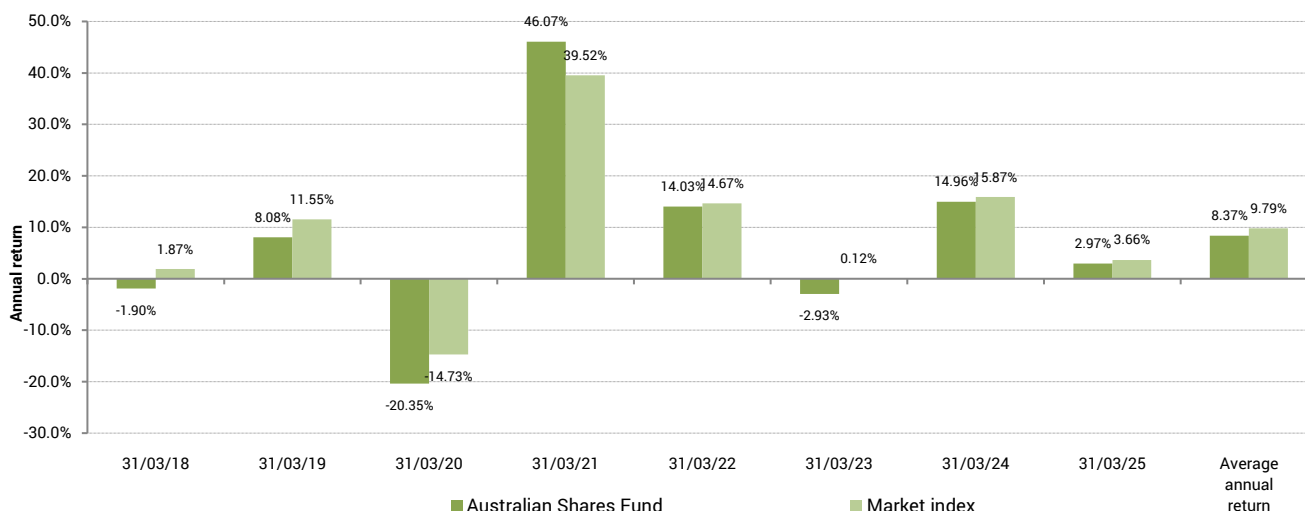

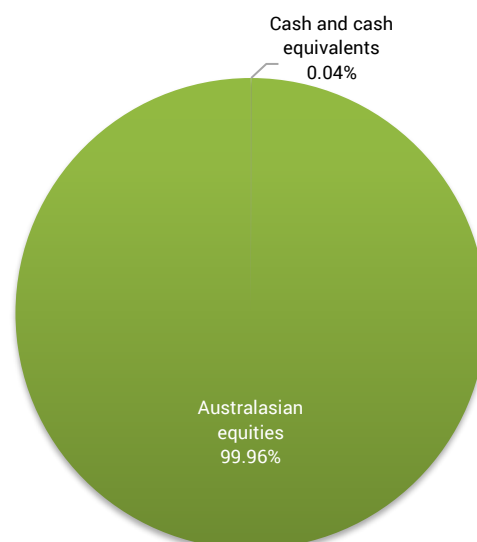
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$1,275 (that is 12.75% of Jess's initial \$10,000). Jess also paid \$12 in other charges. This gives Jess a total return after tax of \$1,134 for the year.

Currency hedging

As at June 30 2025 the fund's exposure to assets denominated in foreign currencies was 100.06%, of which 49.42% was hedged. This means the fund's unhedged foreign currency exposure was 50.61% of the net asset value of the fund.
