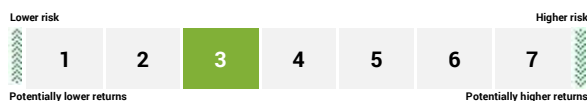
### Description of this fund

### What are the risks of investing?

#### Risk indicator for the Overseas Bonds Fund

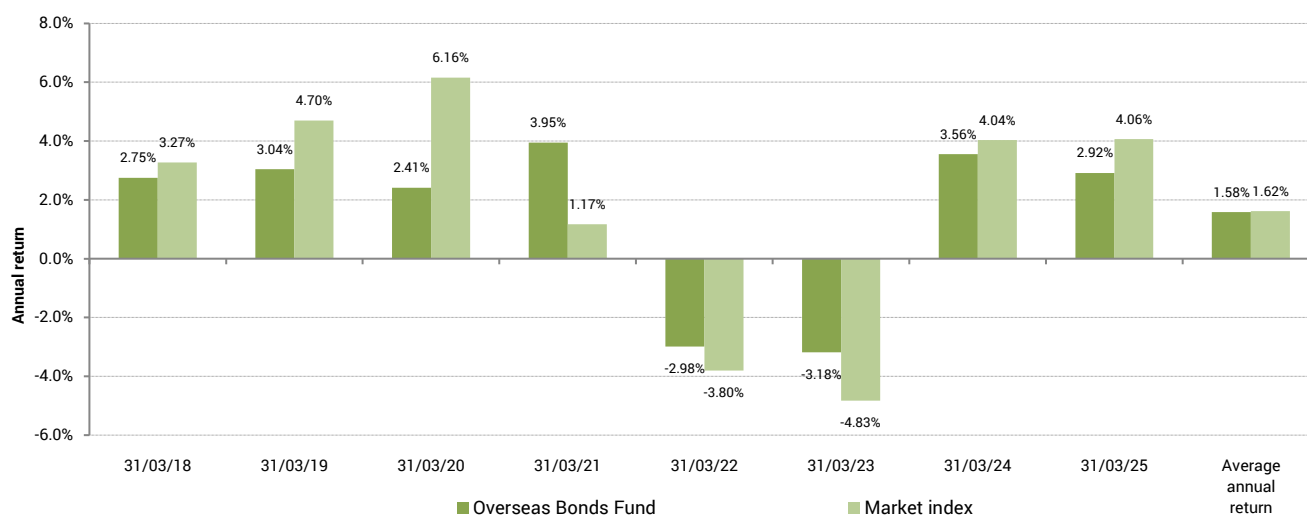

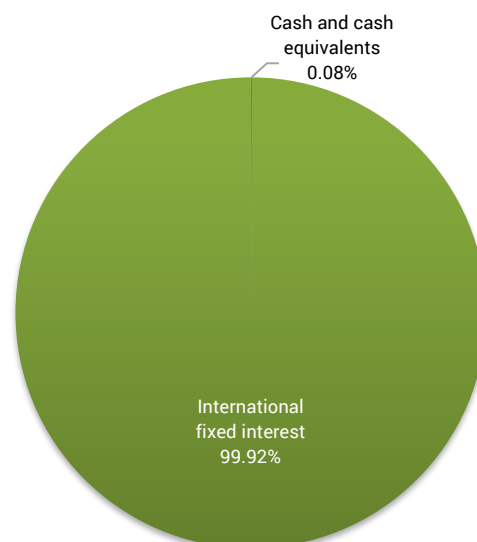
## Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$352 (that is 3.52% of Jess's initial \$10,000). Jess also paid \$12 in other charges. This gives Jess a total return after tax of \$338 for the year.
