What is the purpose of this update?

This document tells you how the Overseas Shares (Currency Hedged) Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in international shares and is designed to track the return (before tax, fees and other expenses) of the MSCI World ex Australia ESG Screened Index (100% NZD Hedged).

What are the risks of investing?

Risk indicator for the Overseas Shares (Currency Hedged) Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

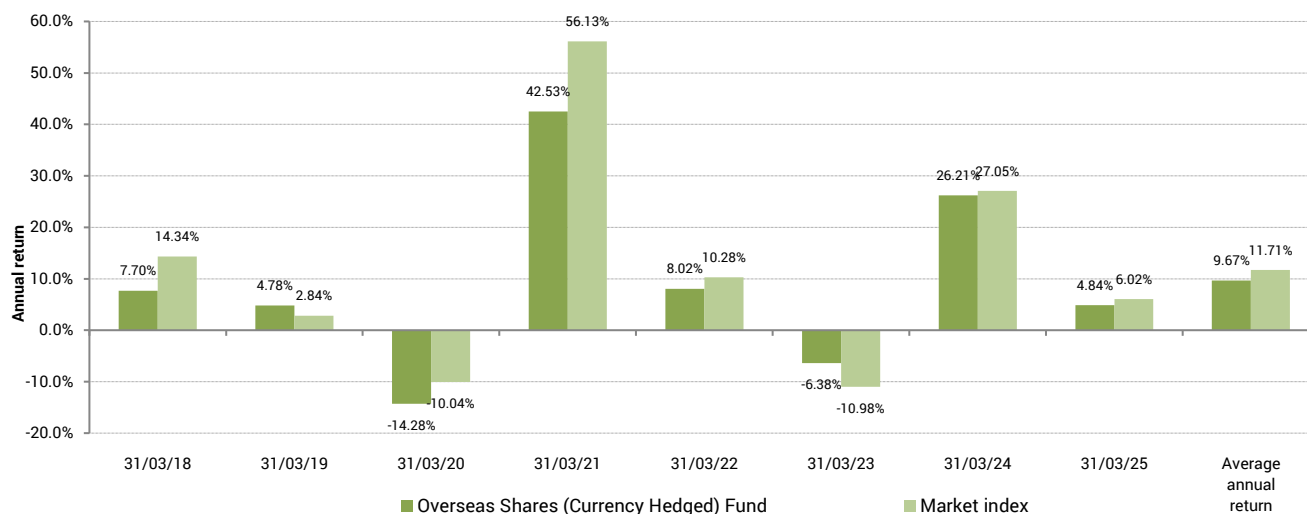
How has the fund performed?

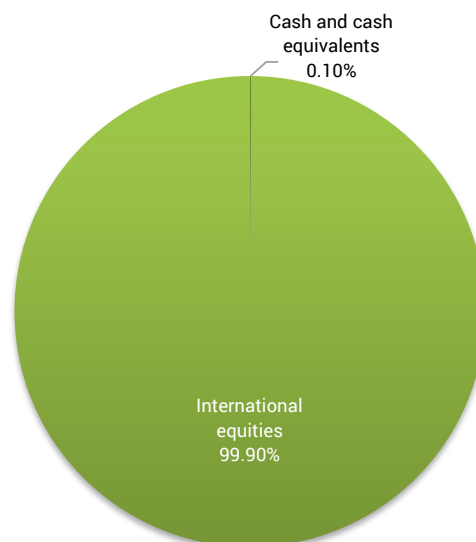
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$1,161 (that is 11.61% of Jess's initial \$10,000). Jess also paid \$12 in other charges. This gives Jess a total return after tax of \$1,111 for the year.

Currency hedging

As at June 30 2025 the fund's exposure to assets denominated in foreign currencies was 99.00%, of which 98.16% was hedged. This means the fund's unhedged foreign currency exposure was 1.82% of the net asset value of the fund.
