## What is the purpose of this update?

This document tells you how the Australian Dividend Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ## **Description of this fund**

Invests in Australian shares and is designed to track the return (before tax, fees and other expenses) of the S&P/ASX Dividend Opportunities Index.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets




## Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$288 (that is 2.88% of Jess's initial \$10,000). Jess also paid \$12 in other charges. This gives Jess a total return after tax of \$132 for the year.
