The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets




## **Example of how this applies to an investor**

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted but before tax of -\$118 (that is -1.18% of Jess's initial \$10,000). Jess also paid \$12 in other charges. This gives Jess a total loss after tax of -\$225 for the year.

#### **Notes**

These charges refer to the normal fund operating costs that are charged to the fund.
