# What is the purpose of this update?

This document tells you how the NZ Top 50 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### **Description of this fund**

Invests in New Zealand shares and is designed to track the return (before tax, fees and other expenses) of the S&P/NZX 50 Portfolio Index.

# What are the risks of investing?

Risk indicator for the NZ Top 50 Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets


# **Example of how this applies to an investor**

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$97 (that is 0.97% of Jess's initial \$10,000). Jess also paid \$12 in other charges. This gives Jess a total loss after tax of -\$13 for the year.
