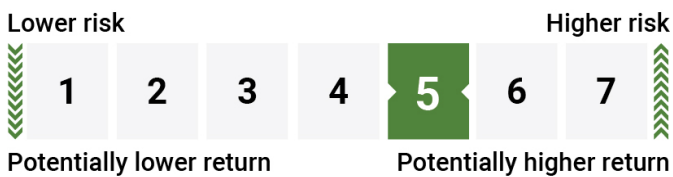
Description of this fund

Invests in international shares and is designed to track the return (before tax, fees and other expense) of the FTSE Emerging Markets All Cap China A Inclusion Index.

What are the risks of investing?

Risk indicator for the Emerging Markets Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

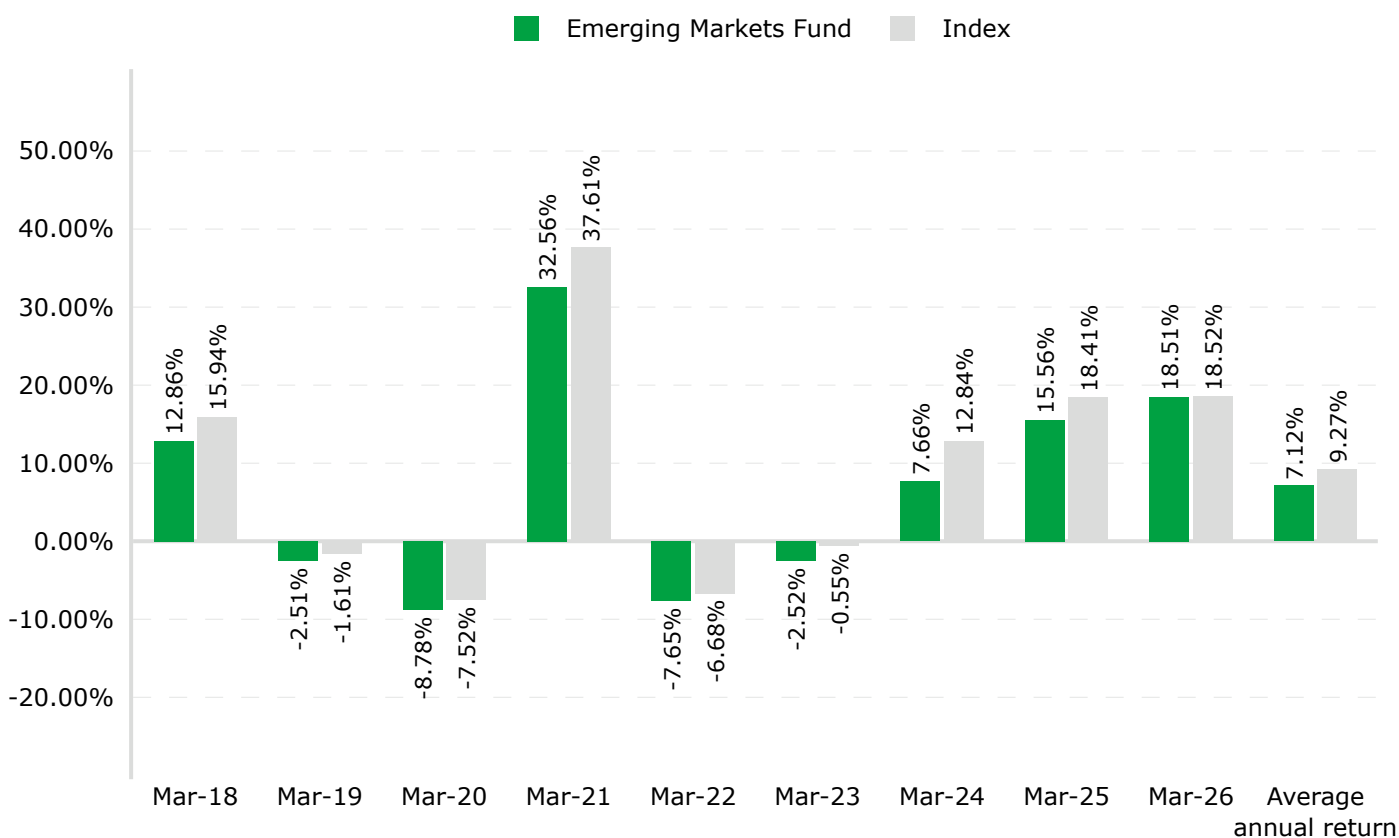

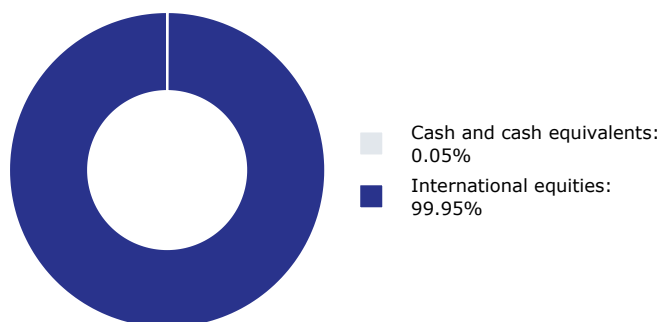
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$1,898 (that is 18.98% of Jess's initial \$10,000). Jess also paid \$12.00 in other charges. This gives Jess a total return after tax of \$1,839 for the year.
