What is the purpose of this update?

This document tells you how SuperLife⁸⁰ has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

SuperLife⁸⁰ invests mostly in growth assets, with a small amount of income assets. Designed for investors that have a long-term investment timeframe. Negative annual returns may occur once in every 3 – 5 years on average.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

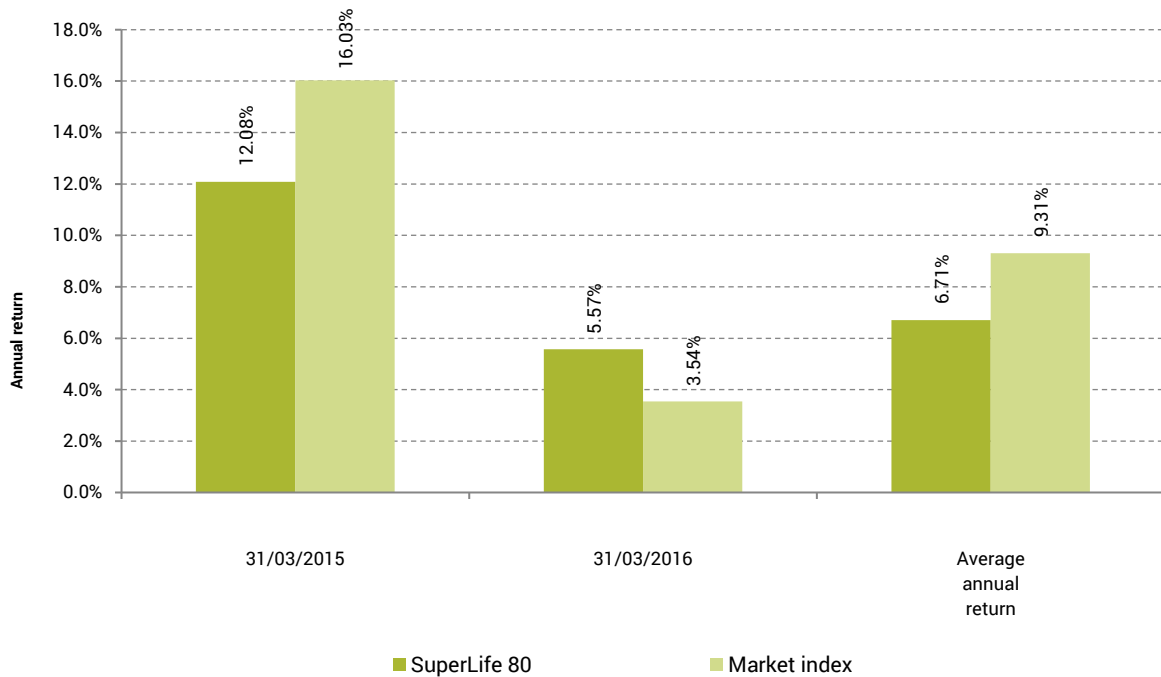

How has the fund performed?

This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2016.

*From 9 November 2016, the total fund charges changed to and estimated 0.65% per annum of the fund's net asset value and the administration fee reduced to \$30 per annum.

Small differences in fees and charges can have a big impact on your investment over the long term.

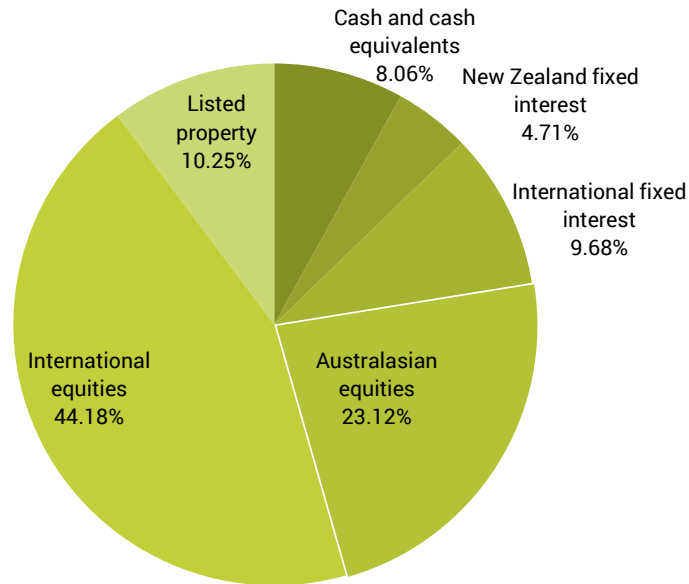
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$781 (that is 7.81% of her initial \$10,000). Jess paid other charges of \$33². This gives Jess a total return after tax of \$748 for the year.

Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. - 2 This is made up of 11 months of \$2.75 per month (when the administration fee was \$33 per annum) and 1 month of \$2.50 (when the administration fee was \$30 per annum).
