# What is the purpose of this update?

This document tells you how Ethica has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

Ethica invests in a mix of income and growth assets. Designed for investors that want a 'balanced' investment option. A socially responsible fund which excludes assets that do not meet the fund's defined ethical investment standards. Negative annual returns may occur once in every 5 - 7 years on average.

Total value of the fund: \$20,523,622

Number of investors in the fund: 1,180

The date the fund started: 31 March 2008

# What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

### **Example of how this applies to an investor**


Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$492 (that is 4.92% of her initial \$10,000). Jess paid other charges of \$32². This gives Jess a total return after tax of \$460 for the year.

- 2 On 9 November 2016, the administration fee changed to \$30 per annum. As a result, the amount set out in the fees table is made up of 4 months of \$2.50 per month (when the administration fee was \$30 per annum) and 8 months of \$2.75 per month (when the administration fee was \$33 per annum).
