

# Fund Update

## SuperLife KiwiSaver scheme

### SuperLife<sup>30</sup>

For the quarter ended 31 March 2017.

This fund update was first made publicly available on 28 April 2017.

### What is the purpose of this update?

This document tells you how SuperLife<sup>30</sup> has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

SuperLife<sup>30</sup> invests mostly in income assets, with a small amount of growth assets. Designed for investors that want a 'conservative' investment option. Negative annual returns may occur once in every 7 - 10 years on average.

### What are the risks of investing?

#### Risk indicator for SuperLife<sup>30</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

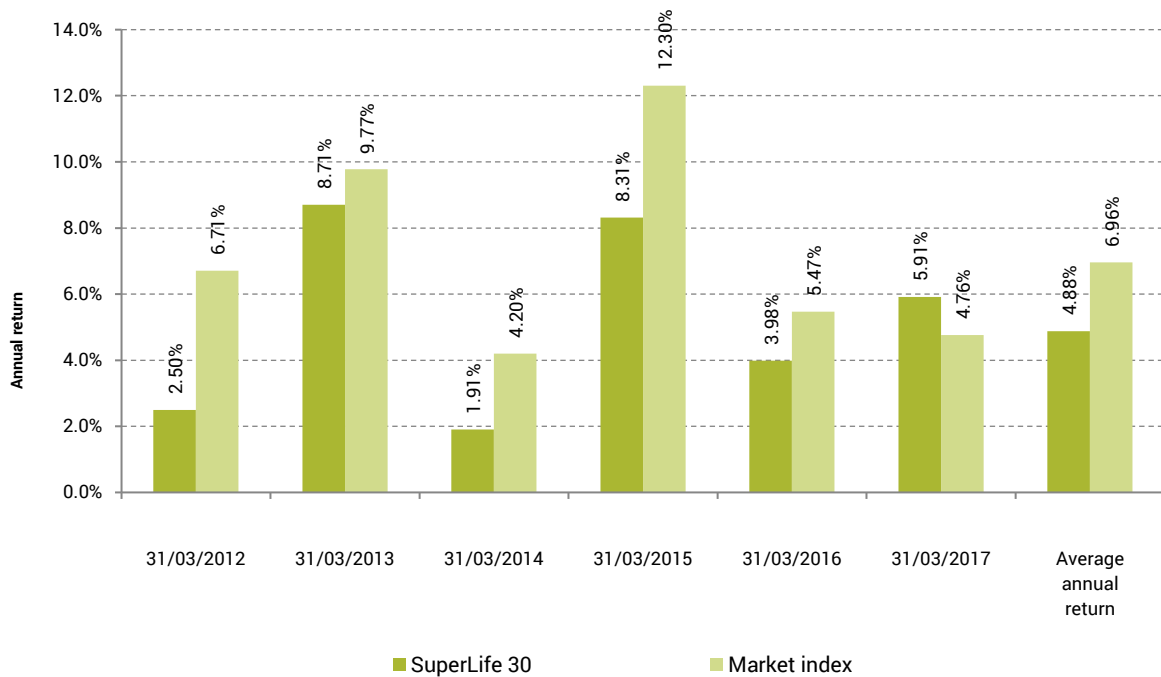

### How has the fund performed?

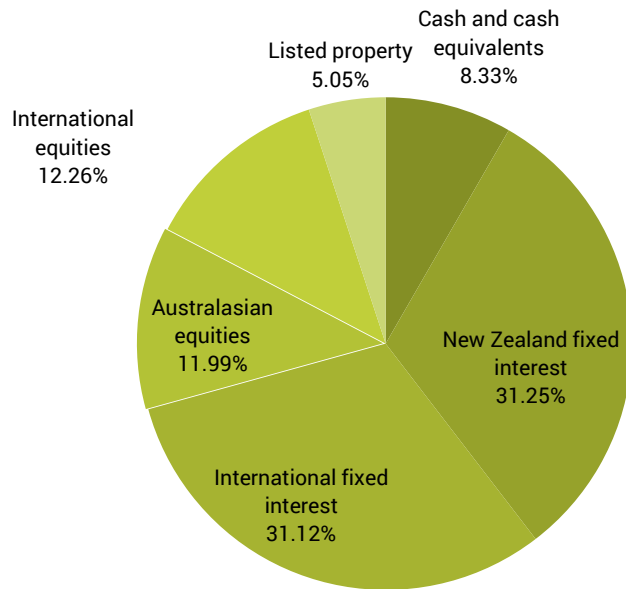
### Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$591 (that is 5.91% of her initial \$10,000). Jess paid other charges of \$32<sup>2</sup>. This gives Jess a total return after tax of \$559 for the year.

- 1 On 9 November 2016, the total management and administration changed to 0.56% per annum. As a result, the total fund charges will be different in the year to 31 March 2018.
- 2 On 9 November 2016, the administration fee changed to \$30 per annum. As a result, the amount set out in the fees table is made up of 4 months of \$2.50 per month (when the administration fee was \$30 per annum) and 8 months of \$2.75 per month (when the administration fee was \$33 per annum).
