## SuperLife<sup>Age Steps</sup> - Age 70

### Investment update for the quarter ended 30 June 2018

This investment update was first made publicly available on 25 July 2018.

### What is the purpose of this update?

This document tells you how SuperLife<sup>Age Steps</sup> - Age 70 (the **stage**) has performed and what fees were charged. The document will help you to compare the stage with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this stage

SuperLife<sup>Age Steps</sup> automatically sets the proportion of your investment in income and growth assets based on your age. As you get older, the proportion of your investment in more volatile growth assets will be reduced, lowering the expected size of the ups and downs in the value of your investment. This option may be suitable if you are saving for retirement (assumed to be age 65), and assumes you will continue to invest your savings and spend them over your retirement period.

Your SuperLife<sup>Age Steps</sup> - Age 70 investment will be allocated 60% to income assets and 40% to growth assets.

### What are the risks of investing?

#### Risk indicator for SuperLife<sup>Age Steps</sup> - Age 70 <sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the stage's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


### How has the stage performed?

The market index annual return is based on the weighted average annual return of the market indices used to measure the performance of the assets that the stage invests in. The market index was changed on 29 June 2018 to ensure the index that the stage is measured against is better aligned to the assets the stage holds.

### Annual return graph





This shows the return after fund charges and tax for each year ending 31 March since the stage started. The last bar shows the average annual return since the stage started, up to 30 June 2018.

Returns in this update are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax may be lower.

### What fees are investors charged?

Investors in SuperLife<sup>Age Steps</sup> - Age 70 are charged fund charges. In the year to 31 March 2018 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

### Example of how this applies to an investor

Jess had \$10,000 in the stage and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$474 (that is 4.74% of her initial \$10,000). Jess paid other charges of \$30. This gives Jess a total return after tax of \$444 for the year.

## Currency hedging

The NZ Cash Fund, SuperLife<sup>Income</sup> and SuperLife<sup>100</sup> (which are funds the stage invests into) do not hedge their foreign currency exposure, but these funds may invest in other funds which hedge their foreign currency exposure.

## Notes
